Welcome to **BLISS**

Programme Structure

Our Academy programmes are sold as an inclusive package covering admission fees, tuition fees, Host Family (HF) accommodation, and support services (according to the individual destination country). Each destination's price list details all inclusions and exclusions. Payment processes for our European destinations are outlined in separate appendices of the BLISS Group Agent Agreement. All payments are made directly to the relevant destination country.

Payment Processes

1. Academy Programmes

- First instalment deposit required to confirm acceptance on programme.
- Final instalment due at least 8 weeks prior to the programme start date.
- Late applicants: all fees payable in one instalment.
- Details of amounts and deadlines can be found in the relevant appendices.

2. Boarding Programmes

- Invoicing and payment processes vary by BLISS location.
- In some cases, invoices will be issued directly by the BLISS.
- BLISS may also issue an invoice centrally – please discuss your preferred payment plan with your Sales Manager.
- Additional service fees for boarding programmes are outlined in the relevant appendices.
- Private boarding schools may have their own payment schedules.

VAT (European Programmes)

- BLISS Europe programme fees do not include VAT.
- Agents are responsible for charging VAT to their students.
- BLISS Europe Finance offices may request the agent's VAT Number or Business Licence.
- If not provided, VAT may be added to the BLISS Europe invoice at the local national rate.

Commissions

- Most package programmes are NET (no commission paid).
- If you wish to add a back commission, discuss options with your Sales Manager.
- Any commissionable programmes will have payout details in the Agent Agreement.

Programme Inclusions

- Registration and tuition fees at BLISS.
- Host Family accommodation (single or double occupancy, with a student of another nationality where possible).
- Welfare, guardianship, and support package: arrival orientation, monthly contact, and start/end reports to the home agency.
- One termly social or activity event (paid for by BLISS UK).
- Online access to the student handbook and emergency contact numbers.
- 24/7 emergency contact.
- ESOL courses and cultural experiences (extra fees apply).

Programme Exclusions

- Uniform (where required).
- Transport to and from school.
- Extra activities, trips, social events, or sports participation.
- Travel/medical insurance (except where included for AYP visa students).
- Dietary or health supplements.
- UK Student Visa.
- NHS Immigration Health Surcharge (for UK visa applications).
- Commissions.

Tuition Fees Policy and Agreement

Binding agreement between BLISS and parents of enrolled students.

BLISS Tuition Fees - £775 per week OR £9,000 per term for Academy BLISS programmes.

Fees exclude trips, uniform, external exams, equipment, etc.

Payment of Fees

Option 1 Payment in advance by bank transfer at enrolment.

Option 2: First instalment deposit to confirm acceptance. Final instalment due 8 weeks before programme start.

Late applicants: full payment in one instalment.

3. Inability to Pay

4. Missed Payments

Reminder email issued with 48-hour grace period.

Failure to pay results in immediate exclusion until payment is made.

£30 late fee applied weekly (up to 4 times).

Continued non-payment: withdrawal

5. Registration Fee

£50 non-refundable fee per student for first-time enrolment.

6. Notice to Leave

Minimum 2 weeks in writing to the Director.

7. Communication

All fee-related communication must be in writing to the Finance Team. The BLISS Office does not handle student fee matters.
